Mental Health & Substance Use

This interactive facilitator-led online training aims to increase knowledge and awareness to help understand and support mental health and substance use.

Learning Outcomes

By the end of the course you will be able to:

- Recall the prevalence of people with co-existing substance use and mental health issues.
- Describe the relationship between mental health and substance use.
- · Gain an overview of common mental health conditions.
- Identify the impact of stigma in relation to drug use and mental health.
- Identify how to support and signpost people affected by mental health and substance use issues.
- Understand the importance of self-care when working in a support setting.

This course will provide you with an awareness of the main drug related harms and understand the principles of harm reduction.

Learning Outcomes

By the end of the course you will be able to:

- Define the principles of harm reduction and understand the background.
- Recall a range of harms caused by substance use and describe harms from specific substances.

• Identify sources of support to reduce drug related harm and be able to signpost people who use your service.

Learning Outcomes

By the end of the course you will be able to:

- · Identify the impact of parental substance use on children.
- Describe the child's change cycle in parental use and recovery.
- Practise the assessment of risk for children affected by parental substance use.
- Identify ways to actively engage and hear young people's stories.

Trauma & Substance Use

This introductory course will support trauma-informed practice when working with people who are affected by trauma and who use substances.

Learning Outcomes

By the end of the course you will be able to:

- Define the concept of psychological trauma.
- Describe how substance use is used as an adaptive coping response to trauma and its impact.
- Identify how to respond to the needs of those affected by trauma at a trauma-informed level.

Benzodiazepine Awareness

This online training aims to increase awareness and knowledge of Benzodiazepines and participants will have the opportunity to explore current and emerging trends within use of this substance. The training will consider harm reduction and support strategies.

Learning Outcomes

By the end of the course you will be able to:

• Recall the current trends and emerging trends with benzodiazepines including street Valium and unlicensed benzodiazepines.

· Identify the physical and psychological/cognitive effects of benzodiazepines.

• Identify effective strategies and techniques for working with people who use benzodiazepines including harm reduction and anxiety management.

• Describe the role of benzodiazepines in poly-drug use, overdose and DRDs.

• Identify effective strategies and techniques for working with benzodiazepine users including harm reduction and anxiety management.
